### **PAYMENT**

*This booking and your agreement to these terms is secured with payment of the \$150.00 deposit. The booking fee is non-refundable and non-transferable. Cancellations within 60 days of the occasion date will result in the hirer being liable for the full contract amount. Full payment must be made no later than 30 days before the wedding or cash on the day*

*Should your booking require additional time over the times stated, our driver will be happy to assist, providing later bookings will not be affected. An additional charge for each 15 minutes will apply and will be payable to the driver, or we will debit your credit card for your convenience. Also, should the contracted time be exceeded by the Photographer, the additional cost incurred will be the responsibility of the hirer.*

*Any reduction in time will not result in a reduction of the total price quoted and agreed to. Events Chauffeur Services reserves the right to cancel any booking where the Terms & Conditions of Hire are deemed to have not been adhered to.*

### **VEHICLES**

*Events Chauffeur Services reserves the right to provide a replacement vehicle in the case of an emergency. Our vehicles will not be taken on unsealed roads and drivers reserve the right to deny any access to a venue that may put the vehicle and its patrons in an unsafe situation. Events Chauffeur Services does not accept any liability in contract or tort for any injury, damage, loss, delay, additional expenses or inconvenience caused directly or indirectly where they are beyond their control.*
